

The Sixth USML to CCL Regulatory Change

Toxicological Agents

October 15, 2013 to September 30, 2017


Contrary to the trend of decreasing license applications for all other USML to CCL regulatory changes, the license applications for items in category XIV – Toxicological Agents and Category XVIII – Directed Energy Weapons of the United States Munitions List (USML) have increased 11.6% from an average of 89 to 99 per month through September 30, 2017 since the Sixth USML to CCL Regulatory change became effective on December 30, 2016.

Since the sixth USML to CCL regulatory change became effective on December 31, 2016, the average number of BIS license applications for the eight 600-Series items created by this rule is 15 per month through September 30, 2017. The approval rate is 85.6%.

From the effective date of December 31, 2016 to September 30, 2017, U.S. exports of items in the sixth USML to CCL regulatory change –Toxicological Agents items (1x607) under BIS jurisdiction totaled 144 shipments for \$5.0 million.

December 31, 2016 to September 30, 2017




