
Statistics of U.S. Exports of 600-series and 9x515 Items

U.S. exports of 600-Series and 9x515 items from October 15, 2013 to September 30, 2017 totaled 356,192 shipments¹ for approximately \$24.0 billion.

U.S. Exports of 600-Series and 9x515 Items by Value


Effective Date to September 30, 2017 \$million

Effective Date to September 30, 2017






Of the \$24.0 billion in U.S. exports of 600-Series and 9x515 items from October 15, 2013 to September 30, 2017, \$22.4 billion (93.4% of the total) was shipped under BIS jurisdiction; and \$1.6 billion (6.6%) was shipped under DDTC jurisdiction².

IV. Overview of U.S. Exports of 600-Series and 9x515 items under BIS Jurisdiction

Of the \$22.4 billion in U.S. exports of 600-series and 9x515 items under BIS jurisdiction from October 15, 2013 to September 30, 2017, the top 15 destinations were Japan with \$3.4 billion (15.0% of the total value), Canada with \$1.9 billion (8.6%) and United Kingdom with \$1.9 billion (8.3%).

Of the \$22.4 billion in U.S. exports of 600-series and 9x515 items under BIS jurisdiction from October 15, 2013 to September 30, 2017, the ECCN with the top export value is 9A610 for military aircraft and related commodities created by the first USML to CCL regulatory change with \$8.9 billion (39.8% of the total value).

Ranking No. 2 is ECCN 9A515 for "Spacecraft" and related commodities created by the fourth USML to CCL regulatory change with \$5.5 billion (24.6%).

Ranking No. 3 is ECCN 9A619 for military gas turbine engines and related commodities created by the first USML to CCL regulatory change with \$3.6 billion (15.9%).



Of the \$22.4 billion in U.S. exports of 600-series and 9x515 items under BIS jurisdiction from October 15, 2013 to September 30, 2017, licensed exports totaled \$12.2 billion (54.4% of the total); STA totaled \$3.4 billion (15.2%); and NLR to Canada and 9A515.e items to all destinations totaled \$1.9 billion (8.8%).
