What to do Before Looking at Export Clearance

- You determined item is "subject to the EAR."
- You classified item using Commerce Control List (CCL) in supp. no. 1 to part 774 and CCL Order of Review in supp. No. 4 to part 774.
- You reviewed CCL-based license requirements and parts 744 and 746 license requirements and determined whether an EAR authorization is required or No license Required (NLR) designation is applicable.
- If authorization is required, you obtained BIS license, or will use another EAR authorization, such as license exception, VEU authorization, or Temporary General License (TGL); or use NLR if no authorization required.
- Only once 4 above are completed, should you look at export clearance.

Other Export Clearance Requirements

- Destination Control Statement and other information furnished to consignees under § 758.6.
- DCS required on commercial invoice under § 758.6(a)(1), and
- (a)(2), ECCN(s) required on commercial invoice for any 3A001.z, 3A090, 4A003.z, 4A004.z, 4A005.z, 4A090, 5A002.z, 5A004.z, 5A992.z, 9x515 or "600 series" "items" being shipped (*i.e.*, exported in tangible form). For seven ECCNs with .z paragraph, requirement to include classification only applies to commodities specified under .z paragraphs. If commodity is specified under any other paragraph in one of those ECCNs, then requirement is not applicable. For 3A090, identify commodity as either 3A090.a, .b, or .c.





Before Using EAR License Exceptions

- You determined item is "subject to EAR" and requires an EAR authorization.
- For list-based license exceptions, you reviewed Export Control Classification Number (ECCN), if applicable, to determine if list-based license exception(s) is available.
- You reviewed general restrictions under § 740.2 to determine if any of those restricted the use of the license exception; *and*
- You reviewed applicable terms and conditions of license exception you plan to use and determined export, reexport, or transfer (in-country) meets those requirements. (See new License Exceptions and VEU Handout)

7 New License Exceptions and 2 New VEU Authorizations Created since Jan. 2024

- C69 License Exception Medical Devices (MED): See § 740.23 of the EAR.
- C70 Implemented Export Control (IEC): See §§ 740.24 and 740.2 of the EAR for additional restrictions.
- C71 High Bandwidth Memory (HBM): See §§ 740.25 and 740.2 of the EAR for additional restrictions.
- C72 Restricted Fabrication Facility (RFF): See §740.26 of the EAR for additional restrictions.
- C73 Artificial Intelligence Authorization (AIA): See § 740.27(a).
- C74 Advanced Compute Manufacturing (ACM): See § 740.28.
- C75 Exception Low Processing Performance (LPP): See § 740.29.
- C76 Universal VEU (UVEU): See § 748.15(a)(2)(ii).

Export Management & Compliance Division (EMCD) on AES Compliance

- Reviews Automated Export System (AES) records
- AES Internal Transaction Numbers (ITNs)
- Country of destination, value, ECCN, HTS description, etc.
- For certain ECCNs, EEI filings must include paragraph classification "or other control descriptor" in the commodity description (see § 758.1(g)(4)(ii) and (5)).



Change to AES to Better Identify Certain FMS Shipments with Creation of "Category 55"

- In AES, recently created "Category 55" refers to special code used to identify items exported under Foreign Military Sales (FMS) program that are <u>not</u> specifically listed on US Munitions List (USML) categories 1-21, meaning they would normally be considered under Export Administration Regulations (EAR) but are <u>not</u> subject to EAR controls when exported via FMS; essentially, it signifies "non-USML items exported under FMS authority."
